Ordinance No. 101478

ORDINANCE FIXING, REGULATING AND CONTROLLING TRAFFIC
WITHIN THE VILLAGE LIMITS, STOP AND GO SIGNS, REDUCE
SPEED SIGNS, YIELD SIGNS AND INTERSECTION SIGNS

By Resolution offered, seconded, voted on and passed by the Village Board of the Village of Dix, County of Jefferson, State of Illinois, the following Ordinance was adopted at a regular meeting of the Village of Dix at the hour of 7:30 P.M. on Saturday, October 14, 1978, in words as follows:

WHEREAS, the Village of Dix, Inc., is growing in population and growing and expanding industrially; and

WHEREAS much traffic to and from and within the corporate limits of said Village has and is beginning to create traffic problems which needs and requires regulations; and

WHEREAS, the Board of Trustees of the Village of Dix, have determined that an Ordinance regulating speed limits, stop and go signs, intersection signs, yield signs and other signs governing the management of traffic within said corporate limits, is proper, feasible, necessary and required; and

WHEREAS, said Board of Trustees together with the Village President or President of the Village Board, have determined that for the safety and welfare of the residents of said Village as well as the safety and welfare of others using the said highways

and streets of said corporate Village, an Ordinance should be passed and enacted regulating the speed of motor vehicles within said Village limits, erecting stop and go signs, intersection signs, yield signs, slow down signs and any and all other signs, warnings or otherwise, that may be necessary in and about the proper and reasonable regulation of traffic within said corporate limits of said Village of Dix; and

WHEREAS, Illinois State Route #37 extending North and South through said Village of Dix, is largely governed by State laws, rules and regulations; and

WHEREAS, F.A.S. Highway #39 extending East and West through said Village is largely governed by the State and County;

IT IS, THEREFORE, determined that the Village of Dix will work and cooperate with the State and County Highway authorities in the regulation of speed and other traffic warnings and devices along said highway regulating said traffic over and upon said highways.

IT IS FURTHER determined that as to the other streets and highways and byways which are distinctly under the jurisdiction of said Village of Dix and which gives access through the Village or to homes, residences and business places in said Village, shall be governed by the Village Board of Trustees insofar as speed limits on various streets, slow down signs, intersection signs, yield signs, stop and go signs and other signs designed to

control the movement of traffic on the streets and highways of said Village are best left to the Board of Village Trustees, together with its mayor, to determine from time to time in the best interests and safety of all persons then and there using said highways and streets in said Village.

FURTHER, that the passage of rules and regulations regulating said traffic must be voted on and passed by the Village Board of Trustees and may be so done or accomplished at any regular or special meeting of said Board of Trustees.

That publication of said speed limits, regulations, stop and go signs, intersection signs, yield signs or other signs regulating said traffic shall be made known to the public and shall be well and visibly placed so that the public may be well informed at all times; that said rule or regulation regulating signs or traffic control devices must have been made known prior to the placing of said signs or traffic devices at the various places within said Village limits;

This Ordinance No. 10 14 78 shall replace, revoke and terminate all other ordinances regulating speed in said Village.

FURTHER, it is not intended that this Ordinance shall or should include every rule and regulation regulating each and every traffic sign or traffic control device that may or might be deemed advisable in the future, leaving this particular matter to the judgement and discretion of the Village Board or Board of Trustees as they may deem justifiable from time to time.

All rules and regulations shall be reasonable and expedient and their enactment made known at least ten (10) days in advance of their becoming effective.

BE IT FURTHER ORDAINED by the President and Board of Trustees of the Village of Dix, Illinois, that this Ordinance, Ordinance No. 10-14-78, be and is hereby enacted and passed by the Village Board of the Village of Dix, under date of October 14, 1978.
