ORDINANCE NO. 11 23 74 CONCERNING THE CONSTRUCTION OF PIPE LINES OR OTHERWISE UNDERNEATH THE STREETS OF THE VILLAGE OF DIX, COUNTY OF JEFFERSON, STATE OF ILLINOIS, AND FORBIDDING THE CUTTING ACROSS OR DIGGING UP OF SAID STREETS FOR THE PURPOSE OF LAYING PIPE LINES OR OTHERWISE

WHEREAS, it is the desire and wishes and intentions of the Village Board of the Village of Dix, County of Jefferson, State of Illinois, to maintain the streets and roadways within the Village of Dix in as good condition as possible, wear and tear excepted; and

WHEREAS, it has been decided that the laying of water lines, gas lines, sewer lines, or any other utility lines or otherwise, across the streets of said Village is a detriment to the upkeep of said streets causing sinking in the road and great damage to the streets; and

WHEREAS, after due consideration of said matter, and the Board has decided that all construction work requiring the digging into the roadway or road bed of the streets of said Village of Dix is a detriment to the upkeep of said streets and that it has been determined that all such construction work should be under the road by process or processes not requiring the digging into the layer of the street itself;

NOW, THEREFORE, BE IT KNOWN that by this Ordinance in the form of a resolution offered by Riley Taylor and seconded by Max Wilson and carried by the following member voting YEA:

that this Ordinance, Ordinance No. 11 23 74, be now passed and accepted by the Village Board of the Village of Dix, County of Jefferson and State of Illinois, that, as pertains to all construction, no person, corporation, association, partnership, joint venture or otherwise, shall cut across, or dig up the street, within said Village for the purpose of laying pipe line, sewer line, water line or any other form of construction but that said construction must be underneath the road and not over or upon said roadway; the Board having concluded that the cutting across or digging up said roadway for the purpose of laying water lines, sewer lines, gas lines or otherwise, is a distinct detriment to the upkeep of the roads and streets in said Village and IS HEREBY PROHIBITED. Penalty for Violation of this said Ordinance shall be not less than FIVE HUNDRED DOLLARS (\$500.00).

Upon a vote for the passage of said Ordinance, the President of the Village Board, having taken the vote and the same having been voted on as aforesaid, said President of said Village Board declares said Ordinance No. 11 23 74 passed and said Ordinance is hereby declared to be part of the Ordinances, Rules and Regulations in and for the Village of Dix, County of Jefferson and State of Illinois, same so declared this 23rd day of November, 1974.
