ORDINANCE NO. 86 -VILLAGE OF DIX COUNTY OF JEFFERSON STATE OF ILLINOIS

AN ORDINANCE AUTHORIZING THE VILLAGE OF DIX, ROME TOWNSHIP, COUNTY OF JEFFERSON, STATE OF ILLINOIS, TO NARROW THE WIDTH OF JACKSON STREET IN THE SAID VILLAGE OF DIX, ILLINOIS, FROM SOUTH STREET NORTHWARD TO NORTH STREET OR FROM NORTH STREET ON THE NORTH TO SOUTH STREET ON THE SOUTH IN SAID VILLAGE.

WHEREAS, said Jackson Street is now of the width of sixtysix (66) feet and is the only street in said Village of Dix having
a width of sixty-six (66) feet; other streets being of the width
of fifty (50) feet; and

WHEREAS, a petition has been circulated by all the people in the said Village of Dix living on said Jackson Street between North and South Street, petitioning the Village Board of Dix to reduce the width of said Jackson Street now sixty-six (66) feet to a width of fifty (50) feet so as to conform with the other Village streets; and

WHEREAS, it is proposed to reduce said street by taking eight (8) feet equally from each side of the street beginning at North Street on the North and ending at South Street on the South, thereby, reducing the width of said street to fifty (50) feet to conform with the other Village streets; and

WHEREAS, it is anticipated that the reduction of said Jackson Street from sixty-six (66) feet to fifty (50) feet will in no way be detrimental to the property owners and petitioners and residents

living along and on either side of said Jackson Street; and

WHEREAS, it is believed that said reduction would not adversely effect the economic prosperity of the Community but would aid in future real estate transactions to the property owners along said Jackson Street; and

WHEREAS, said Ordianance is sponsored by the following petitioners namely:

all residing on that portion of said Jackson Street, sought to be reduced from sixty-six (66) feet to fifty (50) feet; or in the alternative, having an interest in the Village of Dix, such as President of the local bank, property owners, etc.

NOW THEREFORE BE IT ORDAINED, by the Village of Dix, County of Jefferson, State of Illinois, by and through its duly elected, qualified and presently serving Board of Trustees together with the President of said Village Board as follows: That beginning on Jackson Street at the intersection of said Jackson Street with North Street in the said Village of Dix, and extending southward on the said Jackson Street to the intersection of said Jackson Street with Street with South Street, in said Village said Jackson Street

(50) feet; that in order to do so, eight (8) feet on each side of said Jackson Street shall be taken from said Street and added to the property adjacent thereto and facing said Jackson Street, and continuing from the said North Street all the way down to South Street; said Board of Trustees further authorizes and empowers the Street Department of said Village of Dix to accomplish said reduction in such a manner, way and form so as to be consistent with the upkeep, repair and maintenance as of the other streets in said Village.

The Village Board hereby declares that the accomplishment of the above reduction in the width of said Jackson Street to be in the public interest.

The Village Board of Dix, Illinois, further declares that said provision for the narrowing of said Jackson Street to be within the applicable limitations of powers and duties of the Village Board in said Village of Dix, Illinois.

Further ordained by said Board of Trustees that at such time as this Ordiance shall be finally passed by the Village Board that same shall be published at least Only time; in the Mt. Vernon Register News, the only newspaper published in the County of Jefferson, State of Illinois.

Further ordained by the Board of Trustees that within ten (10) days from the final passage of this Ordinance, same shall be filed in the office of the County Clerk, City of Mt. Vernon, County of

Jefferson, State of Illinois, and copies of this Ordinance in pamplhlet form posted in three.(3) of the most prominent places within the Village of Dix, Illinois.

This Ordinance shall become effective after its final passage and after ten (10) days notice by posting as above specified and after ten (10) days from publication of said Ordinance in the Mt. Vernon Register News.

On Tuesday, December 10, 1985, the Ordinance was introduced, read, passed to second reading and/or amendment stage and passed or continued for third reading on Tuesday, January 14, 1986.

This Ordinance shall supersede any other Ordinances heretofore passed affecting the boundaries or boundary line of the said Jackson Street in the Village of Dix, County of Jefferson, State of Illinois, passed by the Village Council - Board of Trustees, Village of Dix, County of Jefferson, State of Illinois, this 14th day of January, 1986.

First reading and passage to second reading for amendments and set or continued over to Tuesday, January 14, 1986, for third reading and final passage. PASSED ON THIRD READING JANUARY 14, 1986.

This Ordinance shall become effective ten (10) days after posting and publication according to law.
